1. For the purpose of collaboration in both education and academic research, Universidad Libre, Republic of *Colombia* and Pukyong National University, Republic of Korea hereby affirm their intent to promote academic cooperation and exchange as will be of mutual benefit to their respective universities. Universidad Libre and Pukyong National University agree to encourage academic cooperation through research and study in the furtherance of learning and through the stated objectives outlined below:

- 1.1 Academic staff cooperation on collaborative research, lectures and conferences in areas of common interests ;
- 1.2 Exchange of scholars and researchers ;
- 1.3 Exchange of data, documentation and research materials in the field of mutual interest ;
- 1.4 Exchange of students including credit transfer ;
- 1.5 Exchange of academic information and publications ;
- 1.6 Any other collaborative efforts that may deem beneficial to both parties.

2. Collaborative activities or projects between the parties will be subject to further agreement detailing the parties' responsibilities and obligations and the conditions relating to each activity or project.




3. Both universities acknowledge that the visit by faculty from one university to the other shall be subject to the entry and visa regulations of Republic of Colombia and the Republic of Korea and shall comply with the regulations and policies of Universidad Libre and Pukyong National University.



MEMORANDUM OF UNDERSTANDING BETWEEN PUKYONG NATIONAL UNIVERSITY AND  
UNIVERSIDAD LIBRE.

4. This Memorandum of Understanding shall become effective on the date of signing for five years and will be automatically renewed for successive five year periods unless either university gives the other a written notice of its desire to terminate or to revise the Memorandum of Understanding six months prior to the termination of a given five-year period.

5. This Memorandum of Understanding is to be executed in two copies in English.
